In 2004, the Idaho Legislature passed Senate Bill 1260, establishing the Idaho Law Enforcement and Firefighting Medal of Honor Commission. The law was amended in 2005 to include EMS providers. This honor is reserved for those law enforcement officers, firefighters, and EMS providers who have distinguished themselves by exceptional meritorious conduct.

The Medal of Honor Commission is accepting nominations for those officers, firefighters, and EMS providers who will be honored in the coming year's ceremonies. Nominations must be received by email, mail, or hand delivery by **December 31, 2026**. Please note the mailing address above. The Attorney General's Office is located on the second floor of the State Capitol, Suite 210, in Boise. The Commission is requesting that the nominating agency have a representative available, either in person or by video or telephone conference, when the Commission meets on **February 9, 2027, at 10:00 a.m.**, to review the nominees.
